In the event of termination of employment due to death, disability or retirement (defined as age 55 and 10 years of service or age 62), the RSUs will vest on a pro-rata basis using the number of full months employed during the thirty-six month vesting period.
- Includes restricted stock units acquired through deemed dividend reinvestment.
- These options become exercisable in three equal annual installments on February 7, 2013, 2014 and 2015.
